

2026 Cut Flower CSA Membership Agreement

This CSA Membership Agreement is between VetREST and

Terms

- VetREST will provide bouquets every other week to all CSA members from **July 2026 through Mid-October 2026** (a total of **8 weeks**).
- This service is provided in exchange for a fee of **\$300**.
- Add-on extras are available in addition to the base subscription.
Veggie Starts: \$30 / Mystery Box \$50 / Native Starts \$50
- **An addition tax deductible program donation of \$150** (or greater) is encouraged.

Payment

- Membership is not active until payment is received in full.
- Members who have not paid will not receive bouquets.
- **No refunds are offered.**
- CSA membership represents a commitment between the member and the farmer.
- If you no longer wish to receive your share, you may **donate your bouquet** to an organization of your choice.

Expectations of Members

1. I agree to arrive at my pick-up location on time or give advance notice if I cannot. I understand the CSA cannot wait past designated times.
2. If I miss my pick-up and do not contact the CSA beforehand, my bouquet will be forfeited and donated to a local organization.
3. I understand that bouquets are made from living, perishable materials, and vase life is not guaranteed. Care instructions are available on the website.
4. Bouquets are composed of seasonally available materials. No specific flowers, colors, or varieties are guaranteed.
5. Bouquets are **not intended for edible or topical use**. Materials may be toxic or irritating if ingested. I agree to hold VetREST free of liability.
6. If I have a concern, I will give the CSA an opportunity to resolve it, including by providing another available item at no cost.
7. I understand that membership involves sharing in the **risks and rewards** of the growing season. Weather, pests, disease, and other unforeseen events may impact production. No guarantees are made.
8. I will automatically be added to the CSA's email list and agree to remain subscribed while I am a paying member, since email is the primary communication method.
